Location of Activity:

Pier N1 – Secondary (Domestic) Navigational Channel

Fraser River upstream of the New Westminster Rail Bridge approximate Latitude 49 12' 30", Longitude 122 53' 32". S1 Pier of the new Pattullo Bridge.

Brief Description of Work:

Dynamic Beast barge to be moved as follows:

- From North Bank to South Bank: Monday, March 18, 2024
- From South Bank to North Bank: Wednesday, March 20, 2024 or Thursday, March 21, 2024.

While moored near North Bank, Dynamic Beast to be lifting structural steel elements from barge to contractor's laydown area on land.

Various barges to be moored on Project area, or nearby moorage, containing bridge materials.

One barge will be moored in the space between the Main Navigational Channel – Downstream and the S1 Pile Cap for a duration of 2 days. Girders on the barge will be hoisted up to bridge deck level for cantilever construction of deck, using the gantry lifter. See sketches on last page.

Hours of Operation:

Up to 16 Hours per day.

Special Requests or Additional Information

Occasional short-term restrictions of the downstream/upstream main and secondary navigational channel will be required between 06:00 to 21:00 within the Start and End Dates/Times to briefly move vessels across the river.

NAV tug assist will be available during the period of this NAVWARN.

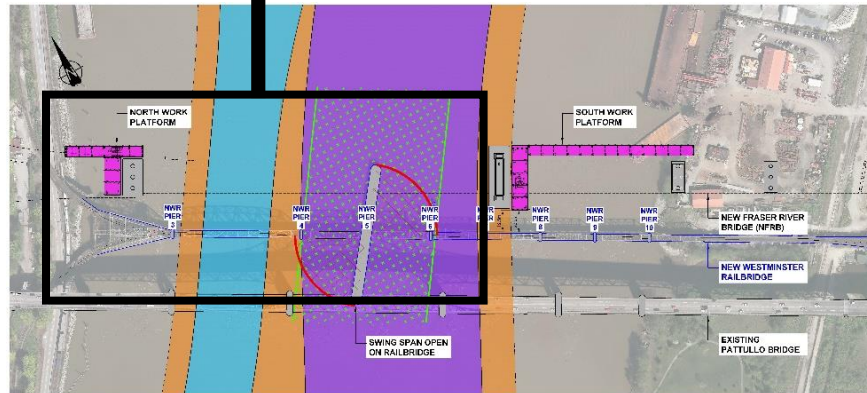
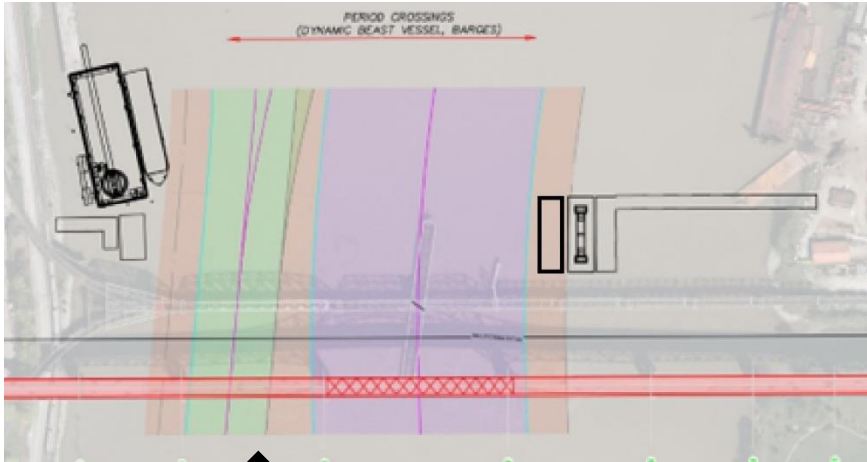

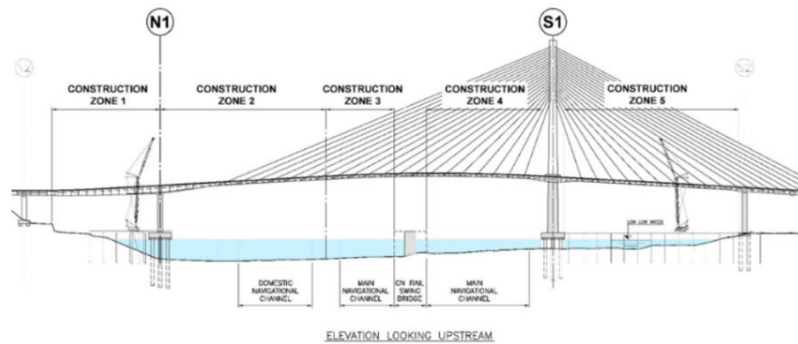
