Removal of the Pattullo Bridge

February 18, 2026

In late February, Fraser Crossing Partners will begin removing the Pattullo Bridge. Deconstruction activities will be completed in three phases: onland, above-water, and below-water. Some removal activities will take place concurrently and the overall process will take approximately two years to complete.

To complete this work, a number of methods and a variety of heavy machinery will be used. As sections of the Pattullo Bridge are removed, materials will be transported to offsite disposal and recycling facilities.

To ensure public safety, temporary road closures will be required in both New Westminster and Surrey to support the removal activities and the completion of on-ramps for the new bridge, as noted below.

New Westminster:

- A local closure of Columbia Street between McBride Boulevard and Elliot Street
- A closure of the Columbia loop-ramp
- A closure of Front Street

Surrey:

- Overnight and weekend closures of Highway 17 and Bridge Road
- Periodic closures of 112/111a Avenue

More information will be provided in advance of all closures, including timing and durations, and as bridge removal activities progress. Impacts to marine navigation are also anticipated, which will be communicated to marine users in advance via Navigational Warnings.

What to Expect



Timing

Starting in late February and continuing for approximately two years.



Hours of Work

In New Westminster, work activities will take place Monday to Friday from 7 a.m. – 8 p.m. and on Saturdays from 9 a.m. – 6 p.m.

In Surrey, work activities will take place Monday to Saturday from 7 a.m. – 10 p.m.

In-river, work activities will take place Monday to Saturday from 7 a.m. – 8 p.m.

Occasional work on Sundays and overnight will be required.



Traffic

Road closures in both New Westminster and Surrey will be required. All closures will be communicated in advance. Traffic control personnel will be onsite to assist as necessary.



Impacts/Interruptions

Nearby residents and businesses can expect to hear noise associated with bridge removal activities. Drivers, pedestrians, and cyclists may experience longer than normal travel times due to detours when road and sidewalk closures are required.
